STATE MEDICAID FACTS

Protect Your Healthcare, Schools and Hospitals

The U.S. House of Representatives has approved \$880 billion in cuts that will likely come from Medicaid.

One plan could cause **231,000 people in Alabama to lose coverage from Alabama Medicaid** (the state's Medicaid program). Alabama would lose \$4.1 billion under another proposal. That money will be made up through firing public service workers, raising taxes or kicking people off of Alabama Medicaid.



medicaid helps 72 MILLION

people with disabilities, veterans, new mothers, retirees, students and low wage workers.

In Alabama, 771,020 people are supported by Medicaid.ⁱⁱⁱ This includes 45% percent of moms giving birth,^{iv} 45% percent of children^v and 68% percent of grandparents and other seniors in nursing homes in Alabama.^{vi} Medicaid also supports veterans, students, working families and AFT members.



medicaid is the LARGEST

health insurance provider for children in the United States and covers about half of all kids.

School health professionals, like speech pathologists, occupational therapists and school nurses and psychologists, all rely on Medicaid funding. Without Medicaid, they will not be able to help as many of the 100,000 students in Alabama schools with disabilities. vii



Medicaid accounts for 19 percent of all payments to hospitals nationwide. VIII Cuts could lead to longer wait times, rushed care, hospital closures and an increase in workplace violence and other challenges faced by our healthcare members. Rural areas and small towns could be impacted the worst, with families having to travel hours for maternity or cancer care. IX



Alabama receives \$6,231,000,001 in federal Medicaid funding annually. *Gutting Medicaid will mean **job losses**—in hospitals, in schools and to Alabama public service jobs.
