### Protect Your Healthcare, Schools and Hospitals

The U.S. House of Representatives has approved \$880 billion in cuts that will likely come from Medicaid.

One plan could cause **8,156,000 people in California to lose coverage from Medi-Cal** (the state's Medicaid program). xlix California would lose \$75.2 billion under another proposal. That money will be made up through firing public service workers, raising taxes or kicking people off of Medi-Cal.



# medicaid helps 72 MILLION

people with disabilities, veterans, new mothers, retirees, students and low wage workers.

In California, 12,199,634 people are supported by Medicaid. This includes 40% percent of moms giving birth, 43% percent of children and 61% percent of grandparents and other seniors in nursing homes in California. Medicaid also supports veterans, students, working families and AFT members.

health insurance provider for children in the United States and covers about half of all kids.

School health professionals, like speech pathologists, occupational therapists and school nurses and psychologists, all rely on Medicaid funding. Without Medicaid, they will not be able to help as many of the 805,000 students in California schools with disabilities. Iv



Medicaid accounts for 19 percent of all payments to hospitals nationwide. California receives \$84,955,000,001 in federal Medicaid funding annually. Viii Gutting Medicaid will mean **job losses**—in hospitals, in schools and to California public service jobs.
