# Protect Your Healthcare, Schools and Hospitals


The U.S. House of Representatives has approved \$880 billion in cuts that will likely come from Medicaid.

One plan could cause **1,351,000 people in Illinois to lose coverage from Medical Card** (the state's Medicaid program).<sup>clvii</sup> Illinois would lose \$21.5 billion under another proposal.<sup>clviii</sup> That money will be made up through firing public service workers, raising taxes or kicking people off of Medical Card.




medicaid helps  
**72 MILLION**  
people with disabilities, veterans, new mothers, retirees, students and low wage workers.

In Illinois, **2,957,608 people** are supported by Medicaid.<sup>clix</sup> This includes **40% percent of moms giving birth,**<sup>clx</sup> **35% percent of children**<sup>clxi</sup> and **69% percent of grandparents and other seniors in nursing homes in Illinois.**<sup>clxii</sup> Medicaid also supports **veterans, students, working families and AFT members.**

**TRAGEDY**  
More patients will use the ER in place of primary care, and staffing and workplace violence in hospitals will worsen if Medicaid funding is cut.

Medicaid accounts for 19 percent of all payments to hospitals nationwide.<sup>clxiv</sup> Cuts **could lead to longer wait times, rushed care, hospital closures** and an increase in workplace violence and other challenges faced by our healthcare members. Rural areas and small towns could be impacted the worst, with families having to travel hours for maternity or cancer care.<sup>clxv</sup>



medicaid is the  
**LARGEST**  
health insurance provider for children in the United States and covers about half of all kids.

School health professionals, like speech pathologists, occupational therapists and school nurses and psychologists, all rely on Medicaid funding. **Without Medicaid, they will not be able to help as many of the 295,000 students in Illinois schools with disabilities.**<sup>clxiii</sup>



medicaid provides

federal funding to states for public services and schools. If Medicaid is cut, jobs will be lost.

Illinois receives \$21,689,000,001 in federal Medicaid funding annually.<sup>clxvi</sup> Gutting Medicaid will mean **job losses**—in hospitals, in schools and to Illinois public service jobs.

**We're in this fight together. Bipartisan groups representing state legislators, state governments, county managers and cities** are concerned about the fate of Medicaid.<sup>clxvii</sup> **And 71 percent of voters who supported President Trump oppose cuts to Medicaid.**<sup>clxviii</sup> We need you to **tell the political leaders and donors in Washington, D.C., to keep their hands off of Medical Card:** [www.actionnetwork.org/letters/medicaid-cuts-2025](http://www.actionnetwork.org/letters/medicaid-cuts-2025).
