### Protect Your Healthcare, Schools and Hospitals

The U.S. House of Representatives has approved \$880 billion in cuts that will likely come from Medicaid.

One plan could cause **875,000 people in Indiana to lose coverage from Indiana Medicaid** (the state's Medicaid program). clxix Indiana would lose \$12.7 billion under another proposal. clxx That money will be made up through firing public service workers, raising taxes or kicking people off of Indiana Medicaid.



# medicaid helps 72 MILLION

people with disabilities, veterans, new mothers, retirees, students and low wage workers.

In Indiana, 1,663,291 people are supported by Medicaid. clxxi This includes 41% percent of moms giving birth, clxxii 37% percent of children clxxiii and 66% percent of grandparents and other seniors in nursing homes in Indiana. clxxiv Medicaid also supports veterans, students, working families and AFT members.

health insurance provider for children in the United States and covers about half of all kids.

School health professionals, like speech pathologists, occupational therapists and school nurses and psychologists, all rely on Medicaid funding. Without Medicaid, they will not be able to help as many of the 188,000 students in Indiana schools with disabilities. clxxv



Medicaid accounts for 19 percent of all payments to hospitals nationwide. Cuts could lead to longer wait times, rushed care, hospital closures and an increase in workplace violence and other challenges faced by our healthcare members. Rural areas and small towns could be impacted the worst, with families having to travel hours for maternity or cancer care. Closwii



Indiana receives \$13,362,000,001 in federal Medicaid funding annually. Classified Gutting Medicaid will mean **job losses**—in hospitals, in schools and to Indiana public service jobs.
