#### Protect Your Healthcare, Schools and Hospitals

The U.S. House of Representatives has approved \$880 billion in cuts that will likely come from Medicaid.

One plan could cause **703,000 people in Maryland to lose coverage from Maryland Medicaid** (the state's Medicaid program). <sup>ccxlii</sup> Maryland would lose \$10.2 billion under another proposal. <sup>ccxlii</sup> That money will be made up through firing public service workers, raising taxes or kicking people off of Maryland Medicaid.



## medicaid helps 72 MILLION

people with disabilities, veterans, new mothers, retirees, students and low wage workers.

In Maryland, 1,327,165 people are supported by Medicaid. CCXIIII This includes 42% percent of moms giving birth, CCXIIV 33% percent of children CCXIV and 64% percent of grandparents and other seniors in nursing homes in Maryland. CCXIVI Medicaid also supports veterans, students, working families and AFT members.



## medicaid is the LARGEST

health insurance provider for children in the United States and covers about half of all kids.

School health professionals, like speech pathologists, occupational therapists and school nurses and psychologists, all rely on Medicaid funding. Without Medicaid, they will not be able to help as many of the 114,000 students in Maryland schools with disabilities. ccxlvii

# More patients will use the ER in place of primary care, and staffing and workplace violence in hospitals will worsen if Medicaid funding is cut.

Medicaid accounts for 19 percent of all payments to hospitals nationwide. cxiviii Cuts could lead to longer wait times, rushed care, hospital closures and an increase in workplace violence and other challenges faced by our healthcare members. Rural areas and small towns could be impacted the worst, with families having to travel hours for maternity or cancer care. cxxlix



Maryland receives \$11,147,000,001 in federal Medicaid funding annually. <sup>ccl</sup> Gutting Medicaid will mean **job losses**—in hospitals, in schools and to Maryland public service jobs.
