STATE MEDICAID FACTS

Protect Your Healthcare, Schools and Hospitals

The U.S. House of Representatives has approved \$880 billion in cuts that will likely come from Medicaid.

One plan could cause **954,000 people in Massachusetts to lose coverage from MassHealth** (the state's Medicaid program). Caliii Massachusetts would lose \$11.6 billion under another proposal. Caliv That money will be made up through firing public service workers, raising taxes or kicking people off of MassHealth.



medicaid helps 72 MILLION

people with disabilities, veterans, new mothers, retirees, students and low wage workers.

In Massachusetts, 1,460,282 people are supported by Medicaid.cclv This includes 32% percent of moms giving birth,cclvi 35% percent of childrencclvii and 62% percent of grandparents and other seniors in nursing homes in Massachusetts.cclviii Medicaid also supports veterans, students, working families and AFT members.



medicaid is the LARGEST

health insurance provider for children in the United States and covers about half of all kids.

School health professionals, like speech pathologists, occupational therapists and school nurses and psychologists, all rely on Medicaid funding. Without Medicaid, they will not be able to help as many of the 182,000 students in Massachusetts schools with disabilities.cclix

More patients will use the ER in place of primary care, and staffing and workplace violence in hospitals will worsen if Medicaid funding is cut.

Medicaid accounts for 19 percent of all payments to hospitals nationwide. ccix Cuts could lead to longer wait times, rushed care, hospital closures and an increase in workplace violence and other challenges faced by our healthcare members. Rural areas and small towns could be impacted the worst, with families having to travel hours for maternity or cancer care. ccixi



Massachusetts receives \$14,851,000,000 in federal Medicaid funding annually. Colaid Gutting Medicaid will mean **job losses**—in hospitals, in schools and to Massachusetts public service jobs.

We're in this fight together. Bipartisan groups representing state legislators, state governments, county managers and cities are concerned about the fate of Medicaid. And 71 percent of voters who supported President Trump oppose cuts to Medicaid.
