### Protect Your Healthcare, Schools and Hospitals

The U.S. House of Representatives has approved \$880 billion in cuts that will likely come from Medicaid.

One plan could cause **436,000 people in Minnesota to lose coverage from Minnesota Medical Assistance** (the state's Medicaid program). Colorviii That money will be made up through firing public service workers, raising taxes or kicking people off of Minnesota Medical Assistance.



## medicaid helps 72 MILLION

people with disabilities, veterans, new mothers, retirees, students and low wage workers.

In Minnesota, 1,163,025 people are supported by Medicaid. CCIXXIX
This includes 34% percent of moms giving birth, CCIXXIX 32% percent of children CCIXXIX and 53% percent of grandparents and other seniors in nursing homes in Minnesota. CCIXXIII Medicaid also supports veterans, students, working families and AFT members.

School health professionals, like speech pathologists, occupational therapists and school nurses and psychologists, all rely on Medicaid funding. Without Medicaid, they will not be able to help as many of the 152,000 students in Minnesota schools with disabilities. cclxxxiii



Medicaid accounts for 19 percent of all payments to hospitals nationwide. cchooxiv Cuts could lead to longer wait times, rushed care, hospital closures and an increase in workplace violence and other challenges faced by our healthcare members. Rural areas and small towns could be impacted the worst, with families having to travel hours for maternity or cancer care. cclooxv
