## **Protect Your Healthcare, Schools and Hospitals**

The U.S. House of Representatives has approved \$880 billion in cuts that will likely come from Medicaid.

One plan could cause **3,342,000 people in New York to lose coverage from New York State Medicaid** (the state's Medicaid program).<sup>ccclxxxv</sup> New York would lose \$48.0 billion under another proposal.<sup>ccclxxxvi</sup> That money will be made up through firing public service workers, raising taxes or kicking people off of New York State Medicaid.



In New York, 5,983,032 people are supported by Medicaid.<sup>ccc/xxxvii</sup> This includes 49% percent of moms giving birth, <sup>ccc/xxxviii</sup> 44% percent of children<sup>ccc/xxxix</sup> and 64% percent of grandparents and other seniors in nursing homes in New York.<sup>cccxc</sup> Medicaid also supports veterans, students, working families and AFT members.





School health professionals, like speech pathologists, occupational therapists and school nurses and psychologists, all rely on Medicaid funding. Without Medicaid, they will not be able to help as many of the 525,000 students in New York schools with disabilities.<sup>cccxci</sup>



Medicaid accounts for 19 percent of all payments to hospitals nationwide.<sup>cccxcii</sup> Cuts **could lead to longer wait times, rushed care, hospital closures** and an increase in workplace violence and other challenges faced by our healthcare members. Rural areas and small towns could be impacted the worst, with families having to travel hours for maternity or cancer care.<sup>ccccciii</sup>



New York receives \$60,145,000,000 in federal Medicaid funding annually.<sup>cccxciv</sup> Gutting Medicaid will mean **job losses**—in hospitals, in schools and to New York public service jobs.

We're in this fight together. Bipartisan groups representing state legislators, state governments, county managers and cities are concerned about the fate of Medicaid.<sup>cccxcv</sup> And 71 percent of voters who supported President Trump oppose cuts to Medicaid.<sup>cccxcvi</sup> We need you to tell the political leaders and donors in Washington, D.C., to keep their hands off of New York State Medicaid: www.actionnetwork.org/letters/medicaid-cuts-2025.
