STATE MEDICAID FACTS

Protect Your Healthcare, Schools and Hospitals

The U.S. House of Representatives has approved \$880 billion in cuts that will likely come from Medicaid.

One plan could cause **1,285,000 people in Ohio to lose coverage from Ohio Medicaid** (the state's Medicaid program). cdxxii Ohio would lose \$21.7 billion under another proposal. cdxxii That money will be made up through firing public service workers, raising taxes or kicking people off of Ohio Medicaid.



medicaid helps 72 MILLION

people with disabilities, veterans, new mothers, retirees, students and low wage workers.

In Ohio, 2,637,875 people are supported by Medicaid.cdxxiii This includes 39% percent of moms giving birth, cdxxiv 38% percent of children cdxxv and 63% percent of grandparents and other seniors in nursing homes in Ohio.cdxxvi Medicaid also supports veterans, students, working families and AFT members.



medicaid is the LARGEST

health insurance provider for children in the United States and covers about half of all kids.

School health professionals, like speech pathologists, occupational therapists and school nurses and psychologists, all rely on Medicaid funding. Without Medicaid, they will not be able to help as many of the 278,000 students in Ohio schools with disabilities. cdxxvii

more emergencies, less staff TRAGEDY More patients will use the ER in place of primary care, and staffing and workplace violence in hospitals

will worsen if Medicaid funding is cut.

Medicaid accounts for 19 percent of all payments to hospitals nationwide. cdxxviii Cuts could lead to longer wait times, rushed care, hospital closures and an increase in workplace violence and other challenges faced by our healthcare members. Rural areas and small towns could be impacted the worst, with families having to travel hours for maternity or cancer care. cdxxix



Ohio receives \$24,160,000,000 in federal Medicaid funding annually. Column Gutting Medicaid will mean **job losses**—in hospitals, in schools and to Ohio public service jobs.
