### Protect Your Healthcare, Schools and Hospitals

The U.S. House of Representatives has approved \$880 billion in cuts that will likely come from Medicaid.

One plan could cause **373,000 people in Oklahoma to lose coverage from SoonerCare** (the state's Medicaid program). cdxxxiii Oklahoma would lose \$7.4 billion under another proposal. cdxxxiv That money will be made up through firing public service workers, raising taxes or kicking people off of SoonerCare.



## medicaid helps 72 MILLION

people with disabilities, veterans, new mothers, retirees, students and low wage workers.

In Oklahoma, 910,977 people are supported by Medicaid. CONSINE This includes 52% percent of moms giving birth, CONSINE 47% percent of children CONSINE and 69% percent of grandparents and other seniors in nursing homes in Oklahoma. CONSINE Medicaid also supports veterans, students, working families and AFT members.



## medicaid is the LARGEST

health insurance provider for children in the United States and covers about half of all kids.

School health professionals, like speech pathologists, occupational therapists and school nurses and psychologists, all rely on Medicaid funding. Without Medicaid, they will not be able to help as many of the 120,000 students in Oklahoma schools with disabilities. cdxxxix

will worsen if Medicaid funding is cut.

Medicaid accounts for 19 percent of all payments to hospitals nationwide. cdxl Cuts could lead to longer wait times, rushed care, hospital closures and an increase in workplace violence and other challenges faced by our healthcare members. Rural areas and small towns could be impacted the worst, with families having to travel

hours for maternity or cancer care. cdxli



Oklahoma receives \$7,194,000,001 in federal Medicaid funding annually. Caxili Gutting Medicaid will mean **job losses**—in hospitals, in schools and to Oklahoma public service jobs.
