STATE MEDICAID FACTS

Protect Your Healthcare, Schools and Hospitals

The U.S. House of Representatives has approved \$880 billion in cuts that will likely come from Medicaid.

One plan could cause **1,196,000** people in Pennsylvania to lose coverage from Medical Assistance (the state's Medicaid program). cdlvii Pennsylvania would lose \$23.0 billion under another proposal. cdlviii That money will be made up through firing public service workers, raising taxes or kicking people off of Medical Assistance.



medicaid helps 72 MILLION

people with disabilities, veterans, new mothers, retirees, students and low wage workers.

In Pennsylvania, 2,818,504 people are supported by Medicaid. cdlix This includes 35% percent of moms giving birth, cdlx 39% percent of children cdlxi and 64% percent of grandparents and other seniors in nursing homes in Pennsylvania. cdlxii Medicaid also supports veterans, students, working families and AFT members.



medicaid is the LARGEST

health insurance provider for children in the United States and covers about half of all kids.

School health professionals, like speech pathologists, occupational therapists and school nurses and psychologists, all rely on Medicaid funding. Without Medicaid, they will not be able to help as many of the 358,000 students in Pennsylvania schools with disabilities. cdlxiii

TRACEDY More patients will use the ER in place of primary care, and staffing

and workplace violence in hospitals will worsen if Medicaid funding is cut.

Medicaid accounts for 19 percent of all payments to hospitals nationwide. Cuts could lead to longer wait times, rushed care, hospital closures and an increase in workplace violence and other

hospital closures and an increase in workplace violence and other challenges faced by our healthcare members. Rural areas and small towns could be impacted the worst, with families having to travel hours for maternity or cancer care.cdlxv



Pennsylvania receives \$28,552,000,001 in federal Medicaid funding annually. Collevi Gutting Medicaid will mean **job losses**—in hospitals, in schools and to Pennsylvania public service jobs.
