STATE MEDICAID FACTS

Protect Your Healthcare, Schools and Hospitals

The U.S. House of Representatives has approved \$880 billion in cuts that will likely come from Medicaid.

One plan could cause **417,000** people in Tennessee to lose coverage from TennCare (the state's Medicaid program). ^{dv} Tennessee would lose \$6.5 billion under another proposal. ^{dvi} That money will be made up through firing public service workers, raising taxes or kicking people off of TennCare.



medicaid helps 72 MILLION

people with disabilities, veterans, new mothers, retirees, students and low wage workers.

In Tennessee, 1,271,910 people are supported by Medicaid. dvii This includes 46% percent of moms giving birth, dviii 42% percent of children dix and 57% percent of grandparents and other seniors in nursing homes in Tennessee. dx Medicaid also supports veterans, students, working families and AFT members.



medicaid is the LARGEST

health insurance provider for children in the United States and covers about half of all kids.

School health professionals, like speech pathologists, occupational therapists and school nurses and psychologists, all rely on Medicaid funding. Without Medicaid, they will not be able to help as many of the 132,000 students in Tennessee schools with disabilities. dxi

more emergencies, less staff TRAGEDY More patients will use the ER in place of primary care, and staffing and workplace violence in hospitals

will worsen if Medicaid funding is cut.

Medicaid accounts for 19 percent of all payments to hospitals nationwide. dxii Cuts could lead to longer wait times, rushed care, hospital closures and an increase in workplace violence and other challenges faced by our healthcare members. Rural areas and small towns could be impacted the worst, with families having to travel hours for maternity or cancer care. dxiii



Tennessee receives \$9,533,000,000 in federal Medicaid funding annually. dxiv Gutting Medicaid will mean **job losses**—in hospitals, in schools and to Tennessee public service jobs.
