### Protect Your Healthcare, Schools and Hospitals

The U.S. House of Representatives has approved \$880 billion in cuts that will likely come from Medicaid.

One plan could cause **874,000 people in Virginia to lose coverage from Virginia Medicaid** (the state's Medicaid program). diii Virginia would lose \$15.3 billion under another proposal. diiv That money will be made up through firing public service workers, raising taxes or kicking people off of Virginia Medicaid.



# medicaid helps 72 MILLION

people with disabilities, veterans, new mothers, retirees, students and low wage workers.

In Virginia, 1,613,039 people are supported by Medicaid. dlv This includes 35% percent of moms giving birth, dlvi 31% percent of children dlvii and 62% percent of grandparents and other seniors in nursing homes in Virginia. dlviii Medicaid also supports veterans, students, working families and AFT members.

health insurance provider for children in the United States and covers about half of all kids.

School health professionals, like speech pathologists, occupational therapists and school nurses and psychologists, all rely on Medicaid funding. Without Medicaid, they will not be able to help as many of the 178,000 students in Virginia schools with disabilities.

# More patients will use the ER in place of primary care, and staffing and workplace violence in hospitals will worsen if Medicaid funding is cut.

Medicaid accounts for 19 percent of all payments to hospitals nationwide. dlx Cuts could lead to longer wait times, rushed care, hospital closures and an increase in workplace violence and other challenges faced by our healthcare members. Rural areas and small towns could be impacted the worst, with families having to travel hours for maternity or cancer care. dlxi



Virginia receives \$14,380,000,001 in federal Medicaid funding annually. dixii Gutting Medicaid will mean **job losses**—in hospitals, in schools and to Virginia public service jobs.

We're in this fight together. Bipartisan groups representing state legislators, state governments, county managers and cities are concerned about the fate of Medicaid. And 71 percent of voters who supported President Trump oppose cuts to Medicaid.
